**CONSENT AND RELEASE FOR BIBLE BAPTIST CHURCH**

I do, for myself and for my child, heirs and assignees, hereby irrevocable and unconditionally release, acquit and forever discharge Bible Baptist Church and/or their agents, and volunteers from any and all liability, actions, causes of actions claims, expenses, obligations and damages of any nature whatsoever, which I now have or which may arise in the future, in connection with my child's participation in the described activity or in any other associated activities including but not limited to, any injury to my child or property, even injury resulting in death.

I expressly agree that this release, waiver and indemnity agreement is intended to be broad and inclusive as permitted by the laws of the State of Vermont and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. The Release contains the entire agreement between parties hereto.

I further state that I have carefully read and understand the foregoing release and know the contents hereof and I sign this release as my own free act.
